**FULL AND COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT
BETWEEN NORTHSIDE AT TAOS SKI VALLEY, LLC AND ITS LIMITED ACCESS PERMIT HOLDERS
(SOMETIMES REFERRED TO "NTSV RELEASE")**

In exchange for and in consideration of Northside at Taos Ski Valley, LLC herein "NTSV", issuing a nontransferable access permit to me and making the recreation area, within the NTSV boundaries, available to me for participation in mountain biking, hiking, snowshoeing and trail running, and recognizing that I may decline its permit and choose to mountain bike, hike, snowshoe and trail run elsewhere, I HEREBY FREELY, FULLY AND WITHOUT RESERVATION CONTRACT AND AGREE TO ABIDE BY AND COMPLY WITH THE FOLLOWING TERMS AND CONDITIONS UPON THE PURCHASE AND SALE OF MY PERMIT, AND ALL THE RULES ON THE REVERSE SIDE:

I UNDERSTAND, ACKNOWLEDGE AND AGREE that mountain biking, hiking, snowshoeing, trail running and any related activities can be **EXTREMELY HAZARDOUS** activities because of many reasons, including: (i) natural and manmade obstacles, (ii) stumps, forest growth and debris and rocks, (iii) and other hazards and (iv) other mountain bikers, hikers, snowshoers, trail runners, horseback riders and motorized vehicles on the mountain. Falls and collisions with obstacles and other mountain bikers, hikers, snowshoers, trail runners, horseback riders and motorized vehicles can occur. Trail and road conditions, including bare spots, bumps, vary constantly because of terrain, weather changes and mountain biker, hiker and foot travel use.

I have made a **VOLUNTARY CHOICE** to mountain bike, hike, snowshoe, trail run and/or ride the shuttle, and/or participate in related activities **DESPITE THE RISKS** that they present, and I agree to **ASSUME ANY AND ALL RISKS OF INJURY OR DEATH** which might be associated with or result from my participation in mountain biking, hiking, snowshoeing, trail running and/or shuttling, and/or related activities within the boundaries of NTSV, or wherever the shuttle may pick me up or take me.

I **ACKNOWLEDGE, UNDERSTAND AND AGREE TO COMPLY WITH AND BE BOUND BY** all federal, state, county, municipal and other applicable statutes, laws, ordinances, rules and regulations, including the NTSV Passholder Rules (referred to as "NTSV Rules") on the reverse side.

I **RELEASE FROM LIABILITY AND PROMISE NOT TO SUE NTSV AND AGREE TO INDEMNIFY AND HOLD IT HARMLESS** from any claim or legal action against it or its representatives, agents, officers, directors, trustees, and employees for any damage, injury or death to me or to any person or property, **WHETHER CAUSED BY THE NEGLIGENCE OF PATTISON'S OR PATTISON TRUST OR LESSEES OR PERMITTEES OR AFFILIATES THEREOF OR NTSV (Collectively "The Releasees") OR FOR ANY OTHER REASON.**

I **AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS NTSV, PATTISON'S OR PATTISON TRUST**, representatives, agents, officers, directors, trustees, and employees, of and from any claim, legal action, harm, injury, damage or loss to person and/or property, made on behalf of myself or from **THIRD PARTIES** injured by me, including but not limited to attorney's fees and costs.

I **CONTRACTUALLY AGREE** that any and all disputes between me and NTSV arising from participation in the sports of mountain biking, hiking, snowshoeing, trail running and/or shuttling, and/or any related activities and including any claims for personal injury and/or death, will be **GOVERNED BY THE LAWS OF THE STATE OF NEW MEXICO** and the **EXCLUSIVE JURISDICTION** thereof will be in the state or federal courts of the **STATE OF NEW MEXICO.**

I **ACKNOWLEDGE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT**, that I **AM SIGNING IT FREELY AND OF MY OWN ACCORD** and recognize and agree that **IT IS BINDING UPON ME, AND MY HEIRS AND ASSIGNS**, and in the event that I am signing it on behalf of any minors, I have the full legal authority to do so, and realize the binding effect of this contract on them, as well as on me.

I acknowledge and agree that any photographs or videos taken of me and/or my child while within the boundaries of NTSV may be used for promotional purposes.

I **HAVE READ AND I UNDERSTAND** the terms of the above Full and Complete Release of Liability and Indemnity Agreement and I am signing it freely and of my own accord, realizing **IT IS BINDING UPON ME, MY HEIRS, ASSIGNS. I AM AWARE THAT THIS CONTRACT IS LEGALLY BINDING AND THAT BY SIGNING BELOW I AM WAIVING MY LEGAL RIGHTS. I AM AWARE THAT BY SIGNING THIS CONTRACT I AM RELEASING MY LEGAL RIGHTS. THIS IS A LIABILITY RELEASE READ CAREFULLY BEFORE SIGNING.**

I HAVE READ ALL THE RULES ON THE REVERSE SIDE OF THIS FORM, AND AGREE WITH ALL THE RULES AND AGREE TO ABIDE BY ALL THE RULES AT ALL TIMES.
